- 4. To date, since the implementation of bail reform, how many CDR2 warrants have been issued? How many CDR2 have been issued during the same comparable period in 2016?
- 5. To date, since the implementation of bail reform, how many CDR1 summons have been issued? How many CDR1 summons were issued during the same comparable period in 2016?
- 6. To date, since the implementation of bail reform, how many defendants are being monitored by PTS? Of the total, how many are being supervised under level 1, level 2, level 3, and level 3+? Of the total, how many are being monitored (total and by county) by ankle monitors?
- 7. How many ankle monitors have been allotted to each county? How many specifically does each county have? Of those totals, how many are in use and how many are available?
- 8. How many ankle monitor violations have their been since Jan 1, 2017? Of those defendants that have violated, how many have been remanded back to the jail?
- 9. Of the total defendants being monitored under pretrial, how many pre-trial violations have been reported (total and by county)?
- 10. Of the total defendants that were issued a CDR1, how many have reoffended or been charged with another offense?
- 11. Of the total defendants that were issued a CDR1, how many have subsequently failed to appear at a court appearance? Of those, how many had a FTA warrant issued?

- 27. Please provide copies of all contracts, agreements, and forms that defendants are required to sign relating to PTS, ankle monitoring, or any other PTS monitoring system not covered.
