## Affidavit for Warrant of Arrest and Detention

The Undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement: I have reason to believe and do believe that QUAYLAN SEWELL DOB: 03/19/1998 did then and there, on or about the 20TH day of JULY A.D. 2017, in Austin, Travis County, Texas commit the offense of:

## DELIVERY OF COCAINE WITHIN DRUG FREE ZONE 3RD DEGREE FELONY

Your Affiant Detective A. Cornish, is an investigator assigned to the Austin Police Department's Organized Crime Division. The following information is based on information contained in APD Offense Report #17-6900221.

Responding to complaints of rampant drug sales and an open air drug market outside of the Austin Resource Center for the Homeless (ARCH), the APD Street Narcotics unit began an investigation and surveillance outside of the ARCH. The Street Narcotics Unit identified numerous persons selling crack cocaine and began buying crack-cocaine from the street level dealers. Over an eight day period from June 20, 2017 through July 20, 2017, eighty-one individuals sold crack-cocaine to undercover officers outside of the ARCH.

On July 20, 2017, Officer D. Wright was working in an undercover capacity with the purpose of purchasing crack-cocaine from street level dealers outside of the ARCH on the sidewalks. Officer Wright met with Gretta Green who was later positively identified through the computerized records of the Austin Police Department. Undercover Officer Wright told Green that he was looking for "10", street slang for \$10 worth of crack cocaine.

HALO Camera Operator, M. Henion, observed the following: Green accepted money from Ofc. Wright and walked to a black male wearing a white tank top and blue jeans. The black male was later identified as: Quaylan Sewell b/m 3/19/1998.

Ofc. Henion and Wright observed a hand to hand transaction between Green and Sewell. Green then walked directly back to Ofc. Wright and handed him crack cocaine. Both Green and Sewell were detained and searched due to probable cause. A pre-recorded \$10 bill used to purchase the crack was located on Sewell's person by Ofc. Barreras.

Officer Wright weighed and tested the substance sold to the undercover officer. The substance tested positive for cocaine base and weighed .11 grams.

The undercover officer initialed the location of the cocaine delivery on an APD map of the area. The location indicated and initialed by the undercover officer was less than 1,000 feet from St. David's Episcopal School. St. David's Episcopal Day school is fully accredited by the National Association for the Education of Young Children (NAEYC). They offer traditional child development and Montessori curriculum for ages one through kindergarten. Under Section 481.134, Texas Health & Safety Code, this school is a Drug Free Zone and meets the definition of a "School" under the statute as a private elementary school and day care center.
